If you choose a QUARTERLY or MONTHLY schedule, initial payment of 30% of your annual fee is due August 10th or before.

- α **Applying Students** – A non-refundable application fee of \$70 will be charged for the first student from a family and \$60 for each additional student.
- α **Continuing or Returning Students** – A non-refundable enrollment fee of \$50 will be charged for the first student from a family and \$40 for each additional student.
- α ****application and registration fees are NON-REFUNDABLE**

- α **Category II and Category III students** – An assessment fee of \$25/student will be charged for students who are assessed during enrollment. Assessment includes Kindergarten Roundup.
Category I students – No assessment fee.
- α Late fees are at the discretion of the Administration and will not exceed double the enrollment fees.
- α Fees are calculated using a school quarter as the smallest increment.
- α Discounts are applied only for yearly, semester, and quarterly payments.

IMPORTANT PAYMENT DATES:

- December 20, 2018 50% of Tuition and Capital fees paid (*no report card can be given if a family has not paid 50% by December 20, 2018*)

- March 29, 2019 100% of Tuition and Capital fees paid (*no report card or transcripts can be given if a family has not paid 100% by March 29, 2019*)

In order to operate FIA effectively and efficiently, it is critical that all fees are paid by the deadlines. These are the dates you promise to pay the fees. Please do not put the administration in a position where we need to implement procedures or fines due to lack of payment. FIA tuition and capital fees are among the lowest with international schools in Asia.

If at least 50% of tuition and capital fees are not paid by December 20, 2018, the family will be notified that you can no longer charge any expenses to your account. All expenses will need to be paid in cash at the Business Office. This includes things such as hot lunch, uniforms, library fines, etc. This will remain in effect until the 50% is paid. Remember, full payment must be completed by March 29, 2019. If not, the policy of paying cash will be implemented again.

Starting May 1, 2019, **ALL** families will have to pay cash for **ALL** expenses (*including yearbooks, hot lunches, uniforms, etc.*). Your children cannot receive their final report card or school transcripts if your account is not paid in full.

For children that are returning the 2018-2019 school year, if there is a remaining balance on your 2017-2018 account, your children may not start class until your outstanding balance is paid in full. Accounts can be paid by peso or USD cash, peso or USD check, peso or USD wire transfer, or credit card.
